ORDER

Fee Approval

Before the Honourable Justice Ball on the 12th day of November, 2015.

ON THE APPLICATION of the Plaintiff, Hello Baby Equipment Inc. ("Hello Baby"), coming on for hearing at Regina, Saskatchewan on November 12, 2015, and on hearing Luciana Brasil, counsel for the Plaintiff; and on reading the pleadings and materials filed including the contingency fee agreement between the Plaintiff and Class Counsel, a copy of which is attached to the affidavit of Chelsea Hermanson, affirmed November 3, 2015 (the "Fee Agreement");

THIS COURT ORDERS that:

- 1. the Fee Agreement is hereby approved, pursuant to s. 41 of the *Class Actions Act*, SS 2001, c C-12.01.**

2. a legal fee of \$3,407,500.00 plus disbursements of \$384,571.95 plus applicable taxes on legal fees and disbursements is awarded to Class Counsel with respect to the following settlement agreements:

- (a) between the Plaintiff and BofA Canada Bank and others, dated August 16, 2013 and amended July 7, 2014 and July 8, 2014;
- (b) between the Plaintiff and Citigroup Inc., dated April 22, 2015; and
- (c) between the Plaintiff and Capital One Bank (Canada Branch), dated April 1, 2015;

(collectively, the "Settlement Agreements").

3. Class Counsel legal fees, disbursements and applicable taxes be paid from the total of the settlement funds paid or payable pursuant to the terms of the Settlement Agreements as they become effective.
